Staff have the RIGHT to:	Staff have the RESPONSIBILITY to:
<ul style="list-style-type: none"> <li>• be treated with respect, courtesy and honesty.</li> <li>• teach in a safe, secure and clean environment.</li> <li>• teach in a purposeful and non-disruptive environment.</li> <li>• have co-operation and support from parents and colleagues.</li> </ul>	<ul style="list-style-type: none"> <li>• model respectful, courteous and honest behaviour.</li> <li>• ensure that the school environment, including classrooms and school grounds, are kept safe, secure, neat and tidy.</li> <li>• establish positive relationships with students, colleagues and parents.</li> <li>• plan and monitor student progress.</li> </ul>
Parents have the RIGHT to:	Parents have the RESPONSIBILITY to:
<ul style="list-style-type: none"> <li>• be informed of course and curriculum material, behaviour management procedures, and decisions affecting their child's health and welfare.</li> <li>• be informed of their child's progress.</li> <li>• access a meaningful and relevant education for their child.</li> <li>• be heard in an appropriate forum on matters related to the rights of their child to an appropriate education. E.g. Case conference interviews.</li> </ul>	<ul style="list-style-type: none"> <li>• ensure that their child attends school.</li> <li>• be punctual so students don't miss key instructions and learning.</li> <li>• ensure that their child is physically and emotionally ready for effective learning.</li> <li>• inform the school of any issues that may impact the child's ability to learn and thrive at school.</li> <li>• ensure that their child is provided with appropriate materials to learn.</li> <li>• support the school in providing a meaningful and relevant education for their child.</li> </ul>

Students must have **Good Standing** to participate in Extra-curricular activities.
